# IHHOVISI LOMHLAZIYI- ZIKHALO ZOMSHWALENSE

## Okwenziwa yihhovisi lethu:

- Kuwumsebenzi wethu ukuxazulula:
  - ngokumelene nezinkampani zomshwalense ezingamalungu abhalisiwe
  - ngamapholisi omshwalense okuphila komuntu
- Sixazulula izikhalo ngokubonisana nabathintekile (mediation), iziphakamiso noma – uma sekwehluleke konke – izinqumo.
- Izinqumo zethu ziyabopha ngokomthetho enkampanini yomshwalense eyilungu elibhalisiwe, kodwa hhayi kubafaki-zikhalo. Umfaki-sikhalo angaya enkantolo uma engenelisiwe yisinqumo sethu.
- Abafaki-zikhalo sibasiza mahhala.

## Obani abangakhala kithi?

Noma imuphi umninipholisi, umzuzi, umngena-sikhundleni osemthethweni (isib. umdluliselwa noma umfezi-ntando), umkhokheli-pholisi noma umuntu othathelwe umshwalense onesikhalo ngenkampani yomshwalense ebhalisiwe. Uma ungaqinisekanga, fonela ihhovisi.

## Ngehhovisi lethu

- Sisebenza ngokwemithetho yoMhlaziyi-zikhalo, etholakala ku-website yehhovisi noma ngokuyicela.

  - amapholisi otshalo-mali okungewona okuphila komuntu.
- uma kuyinto eyake yadingidwa wumthetho, edingidwayo njengamanje noma esazodingidwa;
- uma sifakwe emva kweminyaka emithathu nangaphezulu ukusuka osukwini umfaki-sikhalo aba nolwazi noma ekufanele ukuba waba nolwazi ukuthi unesizathu sokukhalaza kithi.
